1	Do you believe that the GC0151 Original Proposal or WAGCM1, WAGCM2, WAGCM3, WAGCM4, better facilitates the Applicable Objectives?	<p>Whilst both the original and WAGCM1 in principle meeting objective (b) reduce the risk of significant repeated tripping causing a major blackout out WAGCM1 does however add another risk that it could restrict the volume of available generation and limit outages might result.</p> <p>WAGCM2, 3 & 4 are as above but also better facilitate objective (d) as currently the Grid Code contains drafting errors which mean there are fault ride through requirements which Generation licensees are unable to achieve compliance.</p>
