# Section 14 Legal Text Review

Section 14 shared with Workgroup Members on 03/07/24

Revisions to the new Section 14 text since last Workgroup review:

1. Removed text referencing when the charging arrangements will be effective from. They will be effective from the start of the Charging Year (Implementation Date)
2. Provided clarification of sites/demand that will be treated as Chargeable Energy Capacity (4pm-7pm) when they are half hourly settled
3. Confirmed need to retain wording 'Subject to 14.17.40.2' to maintain exceptional arrangements for Measurement Class F and G

# Section 14 Legal Text Review – wider review

ESO have conducted a wider review of Section 14 and concluded that the following changes are required:

- 1. 14.17.40.2 removed reference to M15 and full Financial Year as these timings could add confusion when Measurement Class F and G will maintain exceptional arrangements pre and post MHHS migration
- 2. 14.17.40.4 removed reference that suggests this clause is specific to Measurement Class F and G and added reference to 14.17.19

The following clauses within Section 14 were considered but ESO is of the view that these do not require amendments as part of CMP430:

- These clauses could be revised/updated/clarified as part of a future Modification which we would recommend at the end of MHHS Migration
- The recommendation to update these could be superseded by the Demand Charging work being considered by the TNUoS Taskforce
