We would welcome the retention of a process which affords the NESO flexibility to use Project Designation or Connection Point and Capacity Reservation. This flexibility can ensure projects which replace terminated capacity in highly deliverable or system desired regions have assurance on grid connection, and can move quickly to deployment.</p> <p>WACM4 – We do not support the proposed alternative, as in the context of red-line boundaries provided by offshore by the Crown Estate (as denoted by the agreement for lease area). We wish to ensure that connection reform proposals do not codify elements which would consist of agreements between landowners and tenants. To codify any methodologies relating to land that could have implications for the agreements that The Crown Estate has with customers, would create complications and limitations.</p>
