Key areas of discussion

The Chair presented the meeting agenda, which included a review of the timeline updates, action log, licence agreement discussion and Workgroup Report review. followed by any other business and next steps.

Timeline Updates

The Chair explained the timeline updates for the modification, noting changes to the Code Administrator Consultation period and the panel dates.

The Chair noted the tight timeline was due to the urgent nature of the modification, and the need to deliver the Final Modification Report by the 15th of May.

The Proposer mentioned that if a workgroup member cannot attend the meeting for the vote, they can have an alternate or a proxy vote to ensure their vote counts.

The Workgroup agreed to keep the meetings on the 7th, 9th, and 11th of April, with a contingency meeting on the 14th if needed.

The Proposer suggested using the meeting on the 14th to finalise the Workgroup report.

Action Log Review

The Chair reviewed the action log, discussing the status of various tasks including the Q&A from the NESO Teach – in and 5-year Tariff assessment with the NESO Representatives and Workgroup members providing updates on the progress of the actions.

License Agreement Discussion

The NESO Representative updated the Workgroup Members on the status of the licence agreement for accessing the SECULF model noting that the business is reviewing the final draft version of the licence agreement provided by the legal team, and it will be sent out to Workgroup Members by close of play 03 April 2025.

The NESO Representative emphasised that Workgroup Members who sign the licence agreement cannot share the contents of the model with anyone who has not signed the agreement, due to confidentiality obligations.

The NESO Representative mentioned that the process for accessing the SECULF model will be set up internally, and members who sign the agreement will receive the model as soon as practically possible.

A Workgroup Member raised a question about the long-term use of the model for forecasting purposes, and the NESO Representative agreed to take question away for further clarification from the legal team.

Workgroup Report Review

The Workgroup Members reviewed the entire draft Workgroup Report, clarifying comments, actions and identifying areas that needed updates and additional details.

A Workgroup Member suggested clarifying that the proposal section reflects the Proposer's view and rationale for raising the modification.

The Proposer suggested the new five-year tariff analysis from NESO should be included in the report to reflect the updated impact on tariffs.

The Proposer suggested adding a section for the terms of reference, detailing the work group's views on each term and referring to relevant annexes.

The Code Administrator Representative outlined the process for reviewing the report, with comments open until 10:30 AM on Monday 07 April 2025, after which the document will be locked and prepared for the next meeting.
