Key areas of discussion

The aim of Workgroup 3 was to review the draft RES, draft legal text discussions, review the Workgroup Consultation, Terms of Reference and timeline review.

Draft RES

The Workgroup thanked the TO's and representatives for their efforts in preparing the draft RES document. Some Workgroup members raised concerns regarding the draft RES and questioned whether the combined RES document is fit for purpose and if it adequately covers all necessary information for users to purchase equipment to connect to the system and that it isn't missing any vital information from the original documents. The TO Workgroup member explained that the Tos collaborated closely and worked with an external consultant to create the document. They assured Workgroup members that the process involved a broad range of contributors within the company, and the document is considered fit for purpose. However, acknowledged the possibility of missing some details during the compromise process.

The Workgroup agreed that the draft RES should be included within the GC0103 Workgroup consultation to ensure further industry feedback is considered with the caveat that the RES follows a separate governance process from the modification process itself and any feedback would be passed on to the TOs for consideration before the formal RES governance process.

Draft legal text discussions

The Workgroup discussed the draft legal text for GC0103, emphasising the need for a simple and clear obligation on the TO's to have a harmonised approach. A Workgroup member also noted that the Grid Code sections related to electrical standards should be reviewed.

Workgroup Consultation review

The draft Workgroup consultation will be circulated to Workgroup members by 09 April to allow sufficient time to review and provide any comments ahead of the Workgroup consultation being published. The Workgroup will review the draft at the next meeting on 29 April.

Terms of Reference

The Workgroup reviewed the Terms of Reference for GC0103 and had a further discussion on Term of Reference e) Consider any unintended consequences of the modification, including evidence of an impact assessment. The Proposer explained that the impact assessment has been covered through previous emails and the Windsor Review, which highlighted the benefits of harmonization. The Workgroup agreed that this suffices to meet Terms of Reference e). The Proposer confirmed this can be included as evidence for the Workgroup Report.

Timeline

The Workgroup reviewed the timeline for GC0103, noting that the next meeting will be held on 29 April.

- A draft of the GC0103 will be shared for review and comments.
