Key areas of discussion

The Chair presented the meeting agenda, which included a review of the action log, licence agreement discussion and Workgroup Report review. followed by any other business and next steps.

Action Log Review

The Chair reviewed the action log, discussing the status of the outstanding actions and providing updates.

License Agreement Discussion

The Chair advised several participants requested the license agreement in Word format instead of PDF, as the PDF format made it difficult to input names and company details.

The Workgroup Members discussed the nominal payment of one pound required to make the contract binding. Some participants questioned whether this payment needed to be physically sent or if it was just a legal formality. The NESO Representative agreed to take that question away for clarification.

Workgroup Report Review

The Chair took the Workgroup members through the Workgroup report in full, to address all the tracked changes and comments.

A Workgroup Member suggested changing the wording in the overview section to reflect that the modification seeks to improve the cost reflectivity of the transmission charging methodology by removing the locational onshore security factor. The Workgroup Members agreed with this view.

The Workgroup discussed the impact of the modification on tariffs, with suggestions to reword the section in the Workgroup Report to make it clearer.

Public

The Workgroup discussed including both proposed solutions (setting the multiplier to one or removing it entirely) in the proposal section of the Workgroup Report. The Workgroup Members decided to keep both options for clarity.

The Workgroup reviewed post-consultation discussions in the Workgroup Report, including additional analysis and perspectives on the proposed solution. The Workgroup Members were encouraged to review and add their views to the section.

The Workgroup discussed the Legal Text section, agreeing to reference the full Legal Text in an annex and to update the document based on the new baseline.
