Workgroup Report Review

The Chair reviewed the Workgroup Report, mentioning that there were fewer comments than the previous meeting and highlighting new comments from the Workgroup members aiming to finalise and tidy up the Report.

Legal Text Review

The NESO Representative explained the changes made to the legal text, including the removal of references to the Locational Onshore Security Factor and the reworking of calculations, ensuring the changes were verified and approved by the Proposer.

Terms of Reference

The Workgroup reviewed the Terms of Reference for CMP432 and agreed that these had been addressed.

Workgroup Vote

The Chair explained the voting process to the Workgroup before conducting the vote. The Workgroup concluded by majority that the Original better facilitated the Applicable Objectives than the Baseline.
