Key areas of discussion

The Chair outlined the meeting agenda, which included reviewing actions from the last meeting, finalising the legal text, reviewing the Workgroup Report, Terms of Reference, timeline, AOB, and discussing the next steps for the modification.

Actions Log Review

The Proposer provided updates on actions 23–29 to the Workgroup members, confirming that these actions could be officially closed.

Legal Text Review

The legal text was reviewed by the Workgroup, with various comments and suggestions, including changes to terminology, formatting, and classification, raised by Workgroup members.

RMS and EMT Models: The Workgroup discussed the use of RMS and EMT models, with a number of Workgroup members suggesting adding "RMS" in front of "model" to avoid confusion and ensure clarity.

Dynamic Models: It agreed that the text related to dynamic model would be rephrased for better readability.

Small Power Stations: A Workgroup member suggested including a line into the table included within the legal text for Small Power Stations without BEGA for completeness, and the Workgroup agreed to incorporate it.

Workgroup Report Review

The Chair facilitated the review of the Workgroup Report, addressing comments and incorporating amendments suggested by Workgroup members.

It was decided that the remaining comments on the report will be reviewed and updated by Workgroup members. The Chair will add the latest version to the collaboration space for Workgroup members to review ahead of the next meeting.

Terms of Reference Review

The Terms of Reference were thoroughly reviewed by the Workgroup, ensuring comprehensive coverage of all appropriate points. The Chair led the discussion and facilitated the necessary updates.

Workgroup Votes Discussion

The Workgroup discussed the timing of the Workgroup vote, considering the need for a cost recovery mechanism and agreeing to proceed with the vote at the next meeting once the legal text and Workgroup report are finalised.

Next Steps

The Proposer of GC0168 is to Coordinate with the Proposer of the CUSC proposal to draft a solid proposal for the cost recovery mechanism.

The Chair will ensure the legal text and Workgroup report changes are agreed and finalised by email, ahead of the next Workgroup meeting.
