1. Introductions, Apologies and Declarations of Interest

12768. Apologies were received from Trisha McAuley and Ren Walker.

12769. KH declared an interest due to assisting the Proposer in drafting the modification.

2. New modifications

12770. The following new modification was presented to the Panel:

CMP452: Suspension of TNUoS Payments for generators connecting during the 2024/25 charging year

12771. PG noted that the purpose of this Panel meeting was to agree next steps on CMP452, which aims to defer the payments for Generators that connect to the transmission system during 2024/25 until there has been a decision on CMP445. Such deferral would follow a request by a Generator.

12772. CG presented the proposed legal text written by the Proposer and clarified minor changes that the Code Administrator had made to the suggested legal text for clarity, namely ensuring that defined terms were correctly referenced, bolded and capitalised and a minor change to clarify that a decision would only refer to an acceptance or rejection of modification CMP445.

12773. CG presented the timelines for the Modification, noting the differences between the proposed standard timeline and proposed urgent timeline. CG also highlighted risks with the proposed Urgent timeline, due to the time between each stage.

12774. The Panel agreed unanimously that CMP452 has a clearly defined defect, scope and solution, should follow the Urgent Governance Route and should proceed to Code Administrator Consultation.

12775. KH queried the possibility of short-term TEC. DA clarified that it could possibly be an option

12776. The Panel discussed whether a short-term TEC option could be viable, and KH noted that this would be explored by the Proposer to possibly negate the need for CMP452.

12777. CG confirmed that no AOBs was submitted.
