Where we identify the need for additional engagement activities, we will update this transparency statement accordingly.

We will promote these engagement activities through a range of channels, including but not limited to, the NESO website, NESO newsletter, NESO social media and forums, and direct emails to stakeholders that have expressed an interest in RESP. We will also promote tRESP through third party channels where the third party believes their audience may have an interest in RESP. These channels may include energy industry trade associations, local government networks, third party events, and others.

Outputs of each engagement activity will inform the content and nature of future engagements.

Meeting Recordings and Attendees

Some of the events, sessions and workshops associated with tRESP may be video recorded or transcribed to ensure accuracy of information being captured. Participants will be informed if the session is being video recorded or transcribed.

Where video recordings of tRESP engagement events and meetings are to be made, NESO will inform participants prior to the recording. Video recordings will only be shared with relevant parties. Meeting/event minutes will be held internally within NESO and only shared with participants, unless NESO has their permission to share more widely.

RESP Forums will <u>not</u> be video recorded and will only be transcribed for accurate record keeping. We will share the slides and a write-up following the RESP Forums. The write-up will cover all 11 RESP Forums.

Attendee lists from all events and meetings will not be shared externally, unless NESO has the permission of participants to share more widely. The views and information captured from

tRESP events and meetings will only be used to inform the direction and outputs of tRESP. Any questions, comments and feedback received within RESP Forums will be anonymised, unless participants expressly wish for their input to be attributed to them.
