STC Panel Headline Report 21 May 2025

Approval of Panel Minutes

The meeting minutes from the Panels on [29 January 2025](#) and [26 February 2025](#) and the Special Panel on [14 February 2025](#) were approved and have been uploaded to the relevant websites.

Draft Modification

The following draft Modification Proposal was presented to the Panel:

DMP01 Reconciliation Period Extension

Change proposal to extend the period Transmission Owners (TOs) have to reconcile energised projects from 12 months to 2 years.

The Panel concluded that further discussions with TOs and NESO are necessary to refine DMP01 into a comprehensive proposal that incorporates diverse perspectives before its formal submission.

The Proposer will contact NESO with regards to the facilitation of these discussions.

New Modification

The following new Modification Proposal was presented to the Panel:

PM0147 RMS and EMT Model Sharing Process (STCP 12-2 Issue 01)

This modification proposes to introduce a new procedure to govern the interactions between The Company and relevant Transmission Owners (TOs) relating to the exchange of Root Mean Square (RMS) and Electromagnetic Transient (EMT) models.

The Panel noted that additional feedback was provided to the Proposer on the legal text ahead of the Panel meeting and agreed that PM0147 should be resubmitted with the necessary amendments to fully detail the requirements of the proposal.
