Workgroup Meeting 19: CMP316 TNUoS Arrangements for Co-located Generation Sites

Key areas of discussion

The Chair noted the purpose of this Workgroup meeting was to close out the outstanding actions, review the Legal Text and the Code Administration consultation, and confirm that the Terms of Reference have been met before proceeding with the Workgroup Vote.

Actions Review

The Chair provided an update on Action 12, noting that the Proposer had compiled a table outlining the changes and highlighted the corresponding updates in the legal text. The Chair proposed closing the action, and the Workgroup agreed.

Legal Text Review

- The Proposer presented the updated Legal Text, highlighting the addition of a new section to the existing table on generation plant types. This new section introduces the concept of a multi-technology power station and clarifies the associated charging category based on technology type.
- The Proposer noted that several formatting changes had been made since the sendback to improve clarity.

Public

- The Workgroup Members reviewed and agreed on the revised Legal Text. The Chair confirmed that the final version would be circulated to members following the meeting.

WACM1 Legal Text Review

The Proposer presented the WACM1 legal text, noting that it is largely consistent with the original baseline version, with the primary difference being the inclusion of additional acronyms.

The Proposer explained that a scaling element was added to reflect the generic ALF, noting that this change was requested by the WACM1 Proposer to ensure WACM1 delivers its intended outcome.

The Legal Text for WACM1 was presented alongside the baseline to allow members to compare and vote accordingly.

Code Administrator Consultation Discussion

While reviewing the updated Code Administrator Consultation document, the Chair explained that new content had been added to summarise the outcomes of the first Workgroup Vote, the consultation process itself, the second Panel recommendation vote, and Ofgem's decision to send the modification back. The Chair also highlighted a new section outlining how the Send-Back Terms of Reference had been met.

Workgroup Vote

The Chair informed the workgroup that the applicable CUSC objectives had changed and now begin from Objective D. The Workgroup members were asked to keep this in mind when casting their votes.

Public

The Chair confirmed that the voting template would be circulated, and Workgroup members were expected to confirm their vote and submit any accompanying voting statements by close of play on 13 June 2025.

Next Steps

The Chair confirmed the next steps as:

- Submit Code Administration Consultation to CUSC Panel.
- Circulate Voting Form.
- The Chair advised the Code Administration Consultation will run from the end of June – July
- The Chair advised a Special CUSC Panel will hold in August for the DFMR to be voted on and issued to the Authority.
