Workgroup Meeting 1: CMP447 Removal of designated strategic works from cancellation charges/securitisation

### Key areas of discussion

The Chair confirmed that the purpose of the meeting was to provide an overview of modification CMP447 and the modification and workgroup processes.

### Proposer's Presentation

The Proposer of CMP447 presented the modification to the Workgroup, providing information on the defect and proposed solution.

Workgroup members suggested that a worked example would help to understand the details and potential impact of this modification, in particular to clarify how the modification would affect the calculation and securitisation of attributable works. The Proposer took an action to provide this.

Workgroup members enquired about the scope of attributable works and the exclusion of wider works. It was also noted that the current guidance needs updating to reflect [CMP428](#) and its addition of excluded works.

The Proposer took an action to provide a definition of attributable works and non-attributable works to ensure clarity among the group.

Workgroup members requested a clearer presentation of what CMP447 is asking for, what is missing, and the gaps it aims to fill, referencing modifications [CMP428](#) and [CM094](#). The Proposer took an action to provide a detailed presentation on where CMP447 fits within the context of other modifications and the gaps it aims to fill.

## Public

Workgroup members inquired about when the draft legal text will be read for review, highlighting the need for this to be done as soon as possible. The Proposer took an action to work with the NESO legal team to develop the draft legal text based on feedback received during the meeting and share it with Workgroup members as soon as possible.

A Workgroup member raised a point about the impact of CMP447 on the wider works cancellation charge, questioning whether the works removed from attributable works would be included in the zonal wider works cancellation charge.

The Proposer took an action to work with the NESO Connections Team to clarify whether the works removed from attributable works under CMP447 will be included in the zonal wider works cancellation charge.

## Next Steps

The Chair confirmed that the next Workgroup meeting will be held on 26 June.

Workgroup members requested that the Workgroup Consultation period is increased if it is possible based on other factors within the modification timeline. The Chair agreed that the timeline will be reviewed as the workgroup phase progresses.
