Key areas of discussion

The key areas of discussion included updates on outstanding actions, review and refinement of the Workgroup Consultation document and draft Legal Text, consideration of the Terms of Reference, and planning the next steps for finalising the Workgroup Consultation documents

Action Log Review

The Chair reviewed the outstanding actions, closing several actions, and noted the remaining open action regarding raising an alternative modification would be reviewed by the NESO Representatives.

Draft Legal Text Discussion

The draft Legal Text was reviewed, and the Proposer suggested changes to account for multiple charging dates, proposing the term "a relevant charging date" to provide clarity.

The Workgroup debated whether the pro rata charging should be calculated based on days or months, with a decision for the NESO Representative to consult revenue for their preference.

Workgroup Consultation Document Review and Discussion

The Workgroup Consultation document was thoroughly reviewed, with specific attention given to the clarity and relevance of the questions included.

Concerns were raised about the questions related to negative charging zones and immediate tariff changes, leading to a decision to consult with the revenue team to ensure these questions are necessary and appropriately worded.

The next steps involve updating the Workgroup Consultation document based on feedback from the revenue team and sharing it on the collaboration space for final review by the Workgroup Members.
