1. Introductions, Apologies and Declarations of Interest

Other Updates

12848. NH advised the Panel that Ofgem have published their second consultation on the implementation of the energy code reform. The consultation covers their approach to implementing the industry code governance reforms as set out in the Energy Act 2023. The consultation is available on the Ofgem website and will close on 29 May 2025. Any responses should be sent to industrycodes@ofgem.gov.uk.

6. New modifications

12849. No new modifications were presented to the Panel.

7. In flight modification updates

12850. CG talked the Panel through the progression of the in-flight modifications. The in-flight modifications can be found within the CUSC Panel papers pack via the following link: Modification Tracker

<u>CMP344: Clarification of Transmission Licensee revenue recovery and the treatment of revenue adjustments in the Charging Methodology</u>

12851. CG explained to the Panel that upon completion of the final implementation of CUSC Section 14, some discrepancies were identified in clause 14.14.2 due to amendments related to CMP403. There are no material conflicts, and the legal text has been updated. However, the legal text needs to be approved by the Workgroup members before going to Code Administrator Consultation, therefore requires a one-month delay to the timeline. The Panel agreed to the timeline update.

CMP417: Extending principles of CUSC Section 15 to all Users Timeline Update

12852. CG advised the Panel that additional time is required to simplify the solution so it is fully understood by Workgroup members, and to fully discuss and refine the



solution within Workgroup meetings. This revised timeline also takes into account the time that will be required to develop the solution for CM093 which needs to be submitted to the Authority alongside CMP417. The CM093 solution relies on the CMP417 solution being agreed first. The Workgroup Consultation will also run after the CMP448 solution(s) have been finalised within the FMR (according to the current CMP448 timeline) so any interaction with this modification can be taken into account by respondents and reviewed by the Workgroup following the Workgroup Consultation. The Panel agreed to the revised timeline for CMP417.

The next Modification Tracker will be published on 07 May.

8. Workgroup Reports

12853. No Workgroup Reports were presented to the Panel.

9. Draft Final Modification Reports

12854. CG presented the following Draft Final Modification Report to the Panel:

<u>CMP450: Introducing the definition of Dynamic Reactive Compensation Equipment</u> (<u>DRCE</u>) in the <u>CUSC</u>

- 12855. CG delivered a presentation on CMP450. CG explained that this modification seeks to introduce the same definition of Dynamic Reactive Compensation Equipment (DRCE) in the CUSC (Connection and Use of System Code) that currently exists in the Grid Code which ensure consistency.
- 12856. CG confirmed that the Code Administrator Consultation was run from 03 March 2025 to 24 March 2025 and received 0 responses.
- 12857. The Panel held their recommendation vote for CMP450. The Panel recommended unanimously that the Proposer's solution is implemented. The Panel recommended unanimously that the Original better facilitated the Applicable CUSC Objectives. The Final Modification Report will be submitted to the Authority on 14 May 2025. (Post Meeting note: The Final Modification Report was submitted to the Authority on 14 May 2025).

10. Discussion on Prioritisation



12858. The Panel carried out a monthly review of the prioritisation stack, taking into consideration feedback from industry participants. Some Panel members had received feedback from industry regarding CMP447 and the potential commercial impacts this modification could have on users. The CUSC Panel also received a confidential letter to support the evidence of the potential commercial impacts. The Panel held further discussions and unanimously agreed that CMP447 should be given high priority within the prioritisation stack.

The CUSC Panel agreed the following changes to the prioritisation stack:
