# Code Administrator Meeting Summary

Workgroup Meeting 7: The introduction of harmonised Applicable Electrical Standards in GB to ensure compliance with the EU Connection Codes

#### Key areas of discussion

The aim of Workgroup 7 was to review the timeline along with the legal text, Workgroup Consultation Report and update actions.

#### **Legal Text Review:**

The Chair shared details of legal text for review with NESO representatives providing updates sections discussed.

NESO representatives led a review of the Connection Conditions section, identifying areas to be retained and those requiring minor amendments. The Workgroup members strongly emphasised throughout the discussion the need to draft concise legal text.

It was noted that updates made in the Connection Conditions would be reflected in the European Connection Conditions.

The obligation to publish a list of Electrical Standards was discussed. The proposer advised that they had discussed this issue with the NESO Legal team following an action at the previous GC0103 Workgroup meeting and it was suggested retaining the requirement to publish the list but with a slight tweak to the wording to ensure clarity and compliance.

The Workgroup engaged in a thorough discussion regarding updates to the General Conditions. It was agreed that NESO representatives would consult with their legal team and subsequently collaborate with the Proposer to finalise the wording of this section.

## **Review Draft Workgroup Report:**

The Chair expressed appreciation for the contributions to the Workgroup Report and highlighted the importance of addressing the Terms of Reference prior to submission to the Grid Code Review Panel.

The Workgroup systematically reviewed the comments received, addressing each point in detail as they progressed through the report.

## **Applicable Electrical Standards**

The Workgroup proceeded to discuss the proposed applicable electrical standards (AES). A Workgroup member emphasised the importance of ensuring that the AES encompasses Transmission Connection Points all voltage levels and maintains alignment with the Grid Code. It was agreed to review and finalise the AES and Workgroup Report, with a focus on ensuring consistency and addressing any remaining comments.

## **Next Steps**

- NESO Representatives and the Proposer to review and finalise the legal text based on the discussions and circulate it to the Workgroup for final approval.
- The Chair to circulate the current version of the AES document to the Grid Code Panel members for review and comments.
- The Chair to Incorporate the suggested changes and comments into the Workgroup report and circulate the updated version to the Workgroup.
- The Chair and Proposer to revise the timeline to reflect the realistic deadlines and ensure alignment with the AES
