Progress Update

- We have also implemented 106 portal fixes, 58 of these in the last week.
- We have resolved 90% of data issues
- We have 509 open queries as of 11am today and have 2642 which are closed or with customers for confirmation

Upcoming releases*

Application Submission

Resolved issue where customers were unable to progress their application due to a legacy offer/opportunity that had previously been closed or withdrawn. Additional checks added to allow these to progress

Modify Contract Button

Resolved further use cases not resolved in the previous fix allowing customers were unable to progress their applications

Amend Connection Point

Users selecting to amend their connection point but searching their existing are now able to clear the selection on amending their answer to 'no'

Connection Point Amendment

Added a warning message when cancelling a connection point change (when selecting the same point as the existing one) to notify users they are removing any information completed in this section if they proceed



Resolved key Portal challenges

31 July 2025

Queue Formation Page: added clarity to the options that are visible when customers are selecting planning application submitted in the Queue formation section

File upload in Mod apps for advancement: Resolved issue where customers were unable to upload excel files for the DRC upload section in the Mod application for advancement. They are now able to upload Excel files just for this section


Strategic Alignment section: Resolved an issue where customer with multiple technologies selecting one tech for Protections clause 1 and selecting another tech for Protections clause 2a were unable to see the Protection clause 2a section after the protections clause 1 page





How to review my submission

Once the application is submitted, we can go back and view the details of the application.



You can see the different sections marked green and going into any of the sections will be in read only mode as the application is already submitted. You are able to take note of what was submitted and download the files that were attached.
