STC Panel Headline Report 20 August 2025

Approval of Panel Minutes

The meeting minutes from the Panel on 30 July 2025 were approved and these have been uploaded to our <u>website</u>.

Draft Modifications

The following Draft Modification Proposal was presented to the Panel:

PM0133 'Network Services Feasibility Studies'

Creating a defined process/mechanism for the provision of pathfinder feasibility studies.

The Panel reviewed the Draft Modification Proposal, noting that the change is deemed to be material. The Proposer will contact the Authority requesting written approval to proceed, and to clarify the governance route. The Proposer will update the Panel on this modification at the September Panel meeting.

New Modifications

The following new Modification Proposals were presented to the Panel:

CM0102 'Rectification to implementation of various legal text'

This proposal aims to correct the legal text errors in modifications which have been approved by the Authority (CM086, CM087, CM095, CM098, CM099).

The Panel unanimously agreed that CM0102 should follow the Fast-Track Self Governance route and proceed to the Fast-Track Self Governance Appeals Window. CM0102 documentation can be found https://example.com/here/beta-fast-track-new-months/

<u>CM0103 'STC Consequential Modification for CMP447 (follow on Modification to CMP428)'</u>

This modification seeks to introduce consequential changes needed to reflect the new CUSC definitions of terms, if CMP447 is approved as expected towards the end of October 2025.

The Panel agreed unanimously that CM0103 should follow the Self Governance route and proceed to Code Administrator Consultation.
