Update on Panel Minutes

The meeting minutes from the Panels on 17 July 2025 and 24 July 2025 will be presented for approval at the Panel meeting on 25 September 2025.

New Modifications

The following new Modification Proposal was presented to the Panel:

GC0181 'Enhance the Effectiveness of System Incidents Reporting'

Reports are available for industry and the Grid Code Panel to monitor the effectiveness of technical requirements in the Grid Code and Distribution Code – GC0105 and GC0151. The data and the reports are not effectively serving their purpose due to the way the system incidents are being reported. This modification aims to be a further improvement of GC0105.

The Panel agreed by majority that GC0181 should follow the Standard Governance route and unanimously agreed it should proceed to a Workgroup. The Panel agreed the Terms of Reference for the Workgroup.

The Panel agreed for the Workgroup to reconvene and directed that a second Code Administrator Consultation is needed to be run before it is re-presented to Panel for Recommendation Vote. The Panel agreed the Terms of Reference for the Workgroup.

GC0164 'Simplification of Operating Code No.2 Timeline Update'

GC0183 'Generator and Interconnector Availability During a Severe Space Weather Event Request to change Terms of Reference'

The Panel approved amended Terms of Reference as submitted within the Panel Papers.

Draft Final Modification Reports

The following Draft Final Modification Report was presented to the Panel:

GC0174 'Review of obligations to provide EU Transparency Availability Data as specified in OC2.4.7'

To amend Grid Code Section OC2.4.7 as this is referencing the requirements to provide specific data detailed in Schedule 6 of the Data Registration Code (DRC) which is also being amended under this proposal.

The Panel has recommended unanimously that the Proposer's solution better facilitate the Grid Code Applicable Objectives. The Final Modification Report will be sent to Ofgem on 03 September 2025.
