### Key areas of discussion

The aim of Workgroup 4 was to review and finalise the Workgroup Report, confirm the Legal Text and conduct the Workgroup vote.

#### Workgroup Report Discussion

The Chair reviewed each section of the Workgroup Report addressing outstanding comments.

A Workgroup member highlighted their view that if the proposed change is not made, companies may consider reconfiguring their sites, which would result in unnecessary expenditure to adapt their wiring due to historical differences.

A Workgroup member raised concerns around the implementation date of the modification, requesting formal input from NESO IT regarding the feasibility of implementing the change at short notice; the member believed that the impact would be limited to a small number of sites, suggesting 10 or so. NESO's concern had been raised at a previous meeting by the NESO Representative and was formally recorded in their Workgroup consultation response.

The Chair confirmed the concerns raised would be documented in the meeting summary and reflected in the final workgroup report.

#### Legal Text

The Chair confirmed that the Legal Text had not changed since the Workgroup consultation and sought agreement from the Workgroup members to proceed to the vote, with no objections raised.

### **Workgroup Vote**

The Workgroup vote was conducted, with members recording their positions and submitting supporting statements.

3 out of the 6 workgroup members voting, voted overall to recommend implementation of CMP453 original, with 2 recommending baseline (no change), and 1 submitting a neutral vote.

The Workgroup Report is scheduled to be submitted to the CUSC Panel for review on 18 September 2025.
