- 19 Workgroup members voted yes overall that WACM 2 better facilitates against the CUSC non-charging objectives compared to the baseline (the current CUSC).
- 19 Workgroup members voted yes overall that WACM 3 better facilitates against the CUSC non-charging objectives compared to the baseline (the current CUSC).
