Request for Information

Thank you for your request for information which we received on 20 August 2025. As a UK public corporation, NESO is subject to the Freedom of Information Act 2000 (FOIA). Whilst we appreciate that you did not refer to this legislation in your request, your request for information has been forwarded to NESO's Information Rights Team to ensure that any legal rights to information that you may have are considered. The FOIA provides the right of access to recorded information held by a UK public authority subject to certain exemptions.

Your request

You asked us:

"I have read the [North Hyde Substation Review] and I see the line "This was most likely caused by moisture entering the bushing causing a short circuit." Would it be fair to say that the moisture is weather-related and that led to the short circuiting and the subsequent fire?"

Our response

We confirm that we do not hold any information in scope of your request. The cause of the moisture was not considered during the review and hence we do not hold recorded information that would confirm or deny whether the moisture was caused by weather factors.

The Freedom of Information Act does not require us to create new information in order to respond to a request, including requests for NESO to give new opinions. We understand, from the further





information that you provided about the reason for your request, that this is not the response that you may have hoped for. Unfortunately we are not able to provide an opinion or further comment on your question as we did not examine this question as part of our review.

This concludes our response to your request.
