Industry Updates

Net Transfer Capacity update by Elana Byrne, NESO

Elana Byrne gave a Net Transfer Capacity update. See slides for more information.

Summarised as follows:

- A call for input on the 'Methodology for GB Commercial Arrangements relating to Interconnector Capacity Calculation' is open until **5pm** on **19 September 2025**.
- The response proforma is <u>available here</u>.

Cross-border update by Tom Ireland, NESO

Tom Ireland provided a verbal Cross-border cooperation update.

Summarised as follows:

- Confirmed that the ENTSO-E/ UK TSO cooperation agreement, required under the Trade and Cooperation Agreements was signed in June 2025.
- Several Irish TSOs chose not to sign this agreement as they currently permitted to directly cooperation with ENTSO-E as part of Brexit implementation.
- NESO is leading on this engagement on behalf of GB TSOs.
- Two to four high level coordination meetings will occur per year and will act as a steering
 group for working level engagement on three high priority topics: North Sea investment,
 efficient cross border markets and security of critical infrastructure. The groups are yet
 to start, NESO is awaiting reengagement with ENTSOE following the summer period.
