## **Workgroup Meeting 1: Metering Polarity**

## Key areas of discussion

The Chair formally welcomed members to Workgroup 1 and outlined the agenda. The agenda included discussions on the code modification process, Workgroup responsibilities, agreeing on the Terms of Reference, and addressing the Workgroup Consultation process.

#### **Code Modification Process Overview**

The Chair provided a detailed overview of the process, emphasising the roles, responsibilities, and expectations of Workgroup members.

#### **Review Terms of Reference**

The Chair proceeded to review the Terms of Reference, which included Specific focus on implementation arrangements, alignment with the electrical standard, and clarity on power flow.

#### **Proposers Presentation**

The Proposer delivered a comprehensive presentation focusing on metering polarity, its impact on NESO and stakeholders, and the lack of a unified standard.

The proposed solution involves publishing a diagram and supplementary text as a new standard, initially for new connections, with a future stage for legacy systems.

The Workgroup Members discussed practical implementation, cost implications, and the cut-off for new connections.

A Workgroup Member sought clarity on whether the modification applies to TOS, OFTOs, and large demand users, and the need for potential changes to the STC.
