Industry Updates

EU-UK Summit update by Matthew Ramsden, DESNZ

Matthew Ramsden gave a verbal UK-EU summit update, summarising the energy cooperation elements of the May 2025 <u>Common Understanding</u> and noting that exploratory talks are underway with the Commission. Matthew noted the <u>EU-Swiss package</u>, which includes agreement on electricity which JESG members may be interested to read, and asked for JESG members' views on the summit outcomes and in particular the agreement to explore the UK's possible participation in the EU's internal electricity market.

The Chair noted that JESG members broadly welcome the Common Understanding and potential participation in the internal electricity market but stressed the importance of ongoing industry engagement. JESG members noted the potential challenges of alignment with updated EU regulations, especially where IT/system changes are required. Matthew asked stakeholders to reach out with any further views on opportunities or risks.

Joe Peffers (NESO) gave a NTC Innovation report update: Whilst NESO had hoped to have this published, a small number of minor legal issues require clarifying and resolving ahead of publication. NESO anticipate publication being in good time ahead of the next JESG.
