Key areas of discussion

The Chair presented the agenda which included the action log review, Workgroup Report updates, legal text discussion, terms of reference review, and proposed a Workgroup meeting adjustment to ensure sufficient time for thorough document review.

Action Log Review

Action 22 (Action closed) The Executive summary section on the Workgroup report has been made more concise.

Action 23: (Action closed) The NESO Representative drafted and inserted a clear explanation of the triad's purpose and history into the Workgroup Report, with the group refining the language for accuracy and agreeing on its placement and content.

Action 24, 25, 27: (Actions closed): All relate to legal text updates. The NESO Representative addressed these in the legal text review section, with ongoing edits and Workgroup review.

Action 28 (Action closed) The Alternative Proposer reported that amendments had been made to the Workgroup Alternative CUSC Modification 1 (WACM1) section and additional tables added.

Review and updates to the Workgroup Report

The Chair, along with input from Workgroup members, led a detailed review of the Workgroup Report, highlighting completed actions, outstanding updates, and the need for further Workgroup member feedback, particularly on sections involving the Triad explanation, legal text, and data tables.

Terms of Reference (ToR)

The Chair led a line-by-line review of the Workgroup's terms of reference, with input from Workgroup members, confirming that all terms had been fully discussed and met, and identifying

no outstanding issues requiring further group discussion.

Legal Text

The NESO Representative, supported by other Workgroup members, conducted a comprehensive review of the legal text for both the original and WACMI solutions, addressing technical language, calculation methodologies, and ensuring consistency with the intended charging mechanisms, while assigning further actions for clarification and updates.

Next Steps

The Chair noted that the next workgroup meeting will be moved for after key members return from leave, with the timeline potentially adjusted if coverage is unavailable.
