Draft Final Modification Reports

The following Draft Final Modification Report was presented to the Panel:

GC0183 'Generator and Interconnector Availability During a Severe Space Weather Event'

This modification will make changes to the Grid Code to obligate Generators and Interconnectors to notify NESO of their intended position in the event of severe space weather.

The Panel has recommended unanimously that the Proposer's solution better facilitate the Grid Code Applicable Objectives. The Final Modification Report will be sent to Ofgem on 30 October 2025.
