# SQSS Panel Headline Report

## 05 December 2025

### Approval of Panel Minutes

The meeting minutes from the Panel on 29 July 2025 and 31 October 2025 were approved, subject to minor comments from the Panel being incorporated, and these have been uploaded to our website

### New Modifications

The following new Modification Proposals were presented to the Panel:

**GSR035**: ‘System Access Reform; review of the operational requirement in England and Wales’

This modification is proposed to incorporate greater flexibility into the SQSS through probabilistic standard assessments for thermal and voltage constraints in England and Wales to enhance system access and reduce consumer costs, aimed at enabling beneficial outages without compromising system security.

The Panel agreed for the Proposer to review the Proposal form and provide further clarification.

GSR035 documentation will be emailed out to Panel Members to vote on the updated Proposal proceeding to Standard-Governance, along with an updated timeline, prior to the January 2026 SQSS Panel.

**GSR036**: ‘System Access Reform; Review of the Voltage Limits’

This modification is proposed to incorporate greater flexibility by reverting the 275kV upper voltage limit to +10% and explore cascade tripping schemes in

England and Wales to enhance system access and reduce consumer costs—all aimed at enabling beneficial outages without compromising system security.

The Panel agreed for the Proposer to review the Proposal form and provide further clarification, and, additional supporting material.

GSR036 documentation will be emailed out to Panel Members to vote on the updated Proposal proceeding to Self-Governance, along with an updated timeline, prior to the January 2026 SQSS Panel.
