Workgroup Reports

The following Workgroup Report was presented to the Panel:

<u>GC0139 'Enhanced Planning-Data Exchange to Facilitate Whole System Planning'</u>

This modification seeks to increase the scope and detail of planning-data exchange between Network Operators and National Energy System Operator (NESO) to help facilitate the transition to a smart, flexible energy system.

The Panel agreed that the Terms of Reference have been met and agreed for GC0139 to proceed to Code Administrator Consultation. The Code Administrator Consultation will be published on 06 January 2026, and this will close on 06 February 2026.
